International Mechanisms of Human Rights Protection

Professor BAI Guimei

Compulsory course, 2 hours per Weeks, 36 hours in total, 2 credits.

(AIM) This course offers students a thorough overview of the international human rights monitoring mechanisms and the inter-relationship among them. It complements the compulsory course "International Charter of Human Rights".

(CONTENT) The course includes five parts: The first part focuses on Charter-based organs in United Nation and related procedures, such as the personal complaint procedures, special rapporteurs, etc, with the focus on the UN Human Rights Council. The second part centers on the treaty-based organs and the related procedures, such as Human Rights Committee and Committee on the Elimination of Discrimination against Women, etc.. The third part is concentrated on discussions of regional human rights monitoring mechanism, including European Court of Human Rights, the Inter-American Commission on Human Rights, Inter-American Court of Human Rights and African Commission on Human and People's Rights. Due to the absence of the same kind of institutions in Asia (with the ASEAN Intergovernmental Commission on Human Rights as an exception), the course will analyze the possibility of setting up human rights monitoring mechanism according to present situation in Asia. The fourth part will focus on the international courts and tribunals, such as the International Criminal Court and the International Criminal Tribunal for the Former Yugoslavia. The last part will focus on national human rights institutions and its relation to the United Nations and human rights treaty bodies. Cases will be studied in forms of students team work and group discussions. The proportion of lecturing and discussion of the course is 50-50. Group work and case studies will be used during the whole process.

(**RESULT**) On completion of this course, students should be able to:

- (1) Explain and evaluate mechanisms of human rights protection based on the UN Charter:
- (2) Analyze mechanisms of human rights protection based on international human rights conventions;
- (3)Demonstrate a good understanding of regional systems of human rights protection;
 - (4) Critically evaluate national human rights institutions and their roles;

(5) Comment on the inter-relationship between different mechanisms.

(ASSESSMENT)Group work and attendances of discussion comprises 20% of the total points. A short essay (70% of the total points) will be submitted as required by the Law School at the end of the semester. Class attendance will comprise 10% of the total points.
